Dear Sir/Madam,

As informed earlier, Tocilizumab is sourced only through imports from a pharmaceutical company Hoffman La Roche, by Roche India and is marketed in India by Cipla Ltd. While the sale of Tocilizumab to various States/UTs is being undertaken directly by Cipla Ltd. , the Central Govt is making all efforts to ensure that the drug is available across the country. Towards this end, an allocation of 9900 vials (200mg) of Tocilizumab was made for States/UTs along with Central health institutions vide our DO letter dated 30th April, 2021. The Ministry of Health and Family Welfare vide letter No. A-45013/45/2020-HPE-(37) dated 10th May, 2021 has also allocated 50024 vials (80mg) received through donation among States and Central health institutions.

2. Now, as the second lot of Tocilizumab imported for commercial sales has arrived in India on 10<sup>th</sup> May, 2021, please find enclosed a further allocation of 45000 vials of Tocilizumab (80 mg strength). The allocated vials are being placed at the disposal of the Health Department of State Governments/UTs for subsequent allocation to both the Government as well as the Private Hospitals of the concerned State. No separate quantity of Tocilizumab is being allocated directly to the private hospitals located in the States. The Private Hospitals in States should be informed by the State Governments that they have to contact the Health Department of their respective State to source the drug.

3. 2500 vials of central allocation will be at the disposal of the Ministry of Health and Family Welfare for further allocation to Health Institutions under MoHFW. Such institutions may approach Mr Niambuj Sharan, Economic Adviser, MoHFW (nilambuj.sharan@nic.in) for their requirement of Tocilizumab.

4. Another 2500 vials of central allocation will be at the disposal of the Department of Pharmaceuticals for further allocation to Health Institutions under Ministries other than MoHFW. Such Institutions may contact Mr Alok Malviya, Director on attachment in DoP (alok.malviya@nic.in) for their requirement of Tocilizumab.

5. The distribution is being done to States looking only at the recent active case load in the States. The States are requested to prevent hoarding/black marketing and also ensure that the drug is used judiciously strictly according to the treatment protocol advised in the clinical guidance issued by Joint Monitoring Group of MoHFW.

6. The State Governments are requested to widely publicize the mechanism put in place in their respective state of obtaining the allocated vials by the needy patients, Private Hospitals and Government hospitals. The State governments are also requested to keep a record of the subsequent distribution of the allocated quantity and make the information available at the request of the Govt. of India. State Governments are also requested to nominate a nodal officer for management of the allocated stocks and convey the details of the nodal officer (Name, Designation, Mobile, Email id) to the monitoring cell set up under Chairperson, National Pharmaceutical Pricing Authority at monitoring-nppa@gov.in, if not earlier conveyed.
