Subject:- Constitution of Standing Committee on Affordable Medicines and Health Products (SCAMHP).

The Government has decided to constitute a Standing Committee on Affordable Medicines and Health Products (SCAMHP) with the following composition:-

1.	Member (Health), NITI Aayog	Chairman
2.	Chief Economic Adviser, Ministry of Finance	Member
3.	Secretary, Department of Health Research	Member
4.	Vice-Chairperson, NLEM	Member
5.	Joint Secretary, Department of Industrial Policy & Promotion	Member
6.	Director General of Health Services, Ministry of Health & Family Welfare	Member
7.	Subject expert in Biomedical devises/Pharmaceuticals/Bio-technology etc.	Invitee Members

2. The Committee shall be housed in the NITI Aayog and will be serviced by it.
3. Where considered necessary, the Committee may interact with the stakeholders like Civil Society, associations of drug manufacturers and individual experts on the subject under reference.
4. The Committee may also co-opt experts from other Government Departments/Ministries/Organizations/Pharma Associations as and when required.
5. The Terms of Reference of the Committee shall be as follows:
 - (i) The Committee shall be a recommending body to NPPA regarding prices of drugs and health products.

- (ii) The Committee may take a matter for examination, suo-moto or on the recommendations/request of Department of Pharmaceuticals, National Pharmaceutical Pricing Authority and Department of Health & Family Welfare.
6. The Committee will meet periodically as needed.
