Further, revised SPI guidelines were notified on 14.03.2024.

2. Pursuant to the deliberations held with the Industry representatives and after examination of the representations received in this regard, the subscheme RPTUAS has been further modified. The following modifications in the "guidelines of the sub-scheme RPTUAS" are hereby notified:-
