**ORDER**

**Subject: Review applications of M/s Sun Pharmaceutical Industries Limited against NPPA notifications S.O. Nos.1625 (E), 1653 (E) dated 14.06.2013, 1803 (E), 1811 (E), 1817 (E) dated 21.06.2013 fixing price of scheduled medicines under Drugs (Prices Control) Order, 2013 (DPCO, 2013).**

Whereas Government of India, vide price fixation Orders as mentioned below fixed ceiling price of scheduled medicine as mentioned against each of the order:

And whereas aggrieved by the above notifications M/s Sun Pharmaceutical Industries Limited (hereinafter referred to as the Petitioners) had represented to the reviewing authority against the said price fixation. Personal hearing was granted to the Petitioners by the Department of Pharmaceuticals on 23.9.2013. The Petitioners were represented by Shri Chetan Gupta and Shri Sameer Arolkar. On behalf of the NPPA Shri S.K. Bhatt, Deputy Director (Tech) and Shri Manish Goswami, Deputy Director attended the hearing. Shri V.K.Tyagi, DIA, Department of Pharmaceuticals was also present in the hearing as a technical expert.

3. The issues involved in the review application have been examined based on the record of note of discussions of the personal hearing, other documents on record and the Government has decided as under:

The Review applications filed by the Petitioners are disposed of requesting NPPA to revalidate the data by conducting a broad based survey by placing the information on their website and other public modes.
