## Subject: - Amendment in the Operational Guidelines for the Scheme for Promotion of Medical Device Parks w.r.t utilization of previous instalment to claim the subsequent instalment - reg.

Reference is drawn to the Operational Guidelines of the Scheme "Promotion of Medical Device Parks" issued on 27<sup>th</sup> July, 2020 and to the D/o Expenditure OM dated 09.03.2022 (copy enclosed) which mentions "*The Ministries/Departments shall release the funds as far as possible in 'Just-In-Time' manner keeping the float in CNAs account to the minimum possible and shall in no case release more than 25% of the amount earmarked for the scheme in a financial year at a time. Additional funds (not more than 25% at a time) will he released only upon utilization of at least 75% of the funds released earlier and in compliance with the conditions of previous sanction."* 

2. Accordingly, para 17.2 of the Operational Guidelines of the Scheme stand amended and shall now read as follows:
