Subject: Review application of M/s Indi Pharma Pvt. Ltd. under para 31 of DPCO, 2013 against NPPA notification S.O. NO. 3332(E) dated 5th November, 2013 fixing ceiling price of scheduled medicine Clindamycin Tablets (300 mg).

Whereas Government of India, vide price fixation Order No. S.O.3332(E) dated 5th November, 2013 fixed ceiling price of scheduled medicine Clindamycin Tablets (300 mg) under provisions of the Drugs (Prices Control) Order, 2013.

- 2. And whereas aggrieved by the above notification M/s Indi Pharma Pvt. Ltd. (hereinafter referred to as the petitioners) had represented to the reviewing authority against the said price fixation. Personal hearing was granted to the Petitioners by the Department of Pharmaceuticals on 01.01.2014. The Petitioners were represented by Shri K.C. Kohli. On behalf of the NPPA Shri S.K. Bhatt, Deputy Director (Tech) and Shri Manish Goswami, Deputy Director attended the hearing. Shri V.K. Tyagi, Dy. Industrial Adviser, Department of Pharmaceuticals was also present during the hearing as a technical expert.
- 3. The issues involved in the review application have been examined based on the record of note of discussions of the personal hearing, other documents on record and the Government has decided as under:

"As Schedule I covers only Clindamycin Tablets and NPPA has also considered only the prices of tablets, the ceiling price will be applicable to tablets only. NPPA is, however, directed to revalidate the data by appropriate survey of evaluation through all known sources by giving wide publicity through their website and other public media. Till then prices notified by NPPA to be maintained by all."
