Dr.V.K.Subburaj, IAS Secretary (Pharma) chaired the Steering Committee Meeting. At the outset Dr. M. Ariz Ahammed IAS Joint Secretary, Department of Pharmaceuticals welcomed all the participants present. In his address he emphasized the need for deepening relationship and partnership of Phama Industry and NIPERs. He reiterated that Government recognizes and celebrates the contribution of Indian Pharma Industry in making India self-reliant in medicines through availability, accessibility and affordability and in ensuring health security to the nation.

Joint Secretary (Pharma) made a brief presentation on NIPERs-specializations, annual student's intake and pass out numbers and expectations from Industry. Thereupon all 7 NIPERs made their respective presentations informing the strengths and skill sets of their graduates.

All the Industry leaders present offered a number of valuable suggestions on their expectations from the NIPERs while considering career orientation and campus placements of the students. Suggestions were also offered to consolidate and strengthen Academia-Industry linkage to make NIPER graduates industry ready.

Upon in-depth discussion the meet adopted the following resolutions as a Roadmap:

- 1. Pharma Industry welcomed and appreciated the initiative of DoP to build Academia-Industry linkages and observed that this was the first time in the history that both Industry and NIPERs sat down together to harness each other's strengths through convergence and synergy so as to make India a global leader both in generics and drug discovery.
- 2. Action to be taken by the Department of Pharmaceuticals:
 - a) A Steering Committee with the following composition will be constituted to oversee the campus placements and to strengthen Academia-Industry linkage of NIPERs with the Pharma Industry

The Steering Committee will hold meetings once in six months to review the progress.

- **b) Curriculum revision**: DoP will constitute a committee to review the NIPER Curriculum to meet current and future medical needs and industry requirements involving Industry. Industry will provide the names of experts to be included in the said committee. (Action: DoP and All NIPERs; Coordination: NIPER Ahmedabad by May 2016).
- c) Co-ordination: Dr.M.Ariz Ahammed Joint Secretary (NIPER) will facilitate the initiative of Academia-Industry linkage. In case of any difficulty both the NIPERs and Industry are to contact him to resolve the issues.
- 3. Action to be taken by the NIPERs:
 - a) Each NIPER will set up **NIPER-Industry liaison cell** within 30 days and inform all Industry members.(Action: All NIPERs)
 - b) NIPERs collectively will come up with standard templates for Academia-Industry linkage. (Action / Coordination by NIPER Hyd with the help of FITT, IIT Delhi by 15th April 2016)
 - c) Visiting faculty: Industry is ready to extend the services of their experts for the benefit of NIPER students as a visiting faculty. For the purpose, all NIPERs shall identify areas of expertise that they need assistance and contact the nodal officers of 3 associations and individual companies for needful help. (Action: All NIPERs)

- d) **Calendar:** All the NIPERs shall come up with a common placement and career orientation calendar for the benefit of Industry to depute their HRs personnel and other experts. (Action: All NIPERs; Coordination by: NIPER Kolkata by 30.3.2015)
- e) NIPERs should also include case studies, **personality development**, **communication** skills in their curriculum etc. (Action: All NIPERs)
- f) **CEO Talks**: Each NIPER will organize a minimum of 2 CEO talks a year. (Action: All NIPERs).
- g) Customized courses: NIPERs shall develop both short term/ long term courses based on Industry needs. (Action: All NIPERs).
- h) Each of the NIPERs shall **specialize** in different technologies, therapeutic groups, expertise domains etc for deeper partnership with the Industry considering national priorities of disease burden, affordability, foreign exchange etc and future requirements. NIPERs should avoid becoming jack of all trades. Illustrative technologies and therapeutic groups are: (Action: All NIPERs)

- 3. Action to be taken by the Industry side:
 - a) Industry nodal officers: From Industry side the following officials of 3 Associations will extend needful help:

The 3 nodal officers will write to all their Industry members to designate an official as a contact point/ nodal officer to liaison with the NIPERs and inform the same to the NIPERs.

- b) Campus placement and Career orientation: Industry will actively visit NIPERs for campus placements during Feb-March and Career orientation immediately after admission annually as per NIPER common calendar for campus placement and career orientation.
- c) Academia-Industry MOU/linkage: Industry will undertake MOUs with NIPERs on education, research and development, trainings, consultancy, professor chair, finishing school etc.
- d) **Research labs/partnerships**: OPPI members will engage their headquarters to set up their research labs/ partnership with different NIPERs.
- e) Visiting faculty: Industry will extend the services of their expertise for the benefit of NIPER students as a visiting faculty. For the purpose all the NIPERs shall identify areas of expertise that they need and contact the nodal officers of 3 associations for needful help.
- **f) Project work opportunities**: Industry will offer project work opportunities for NIPER students.
- g) **CEO Talks**: Industry CEO will visit NIPERs as part of CEO Talks and will confirm on NIPER requests.
- **h) NIPER Director talks**: Similar to CEO Talks at NIPERs, Industry associations will invite NIPER Directors and faculty in their annual and other thematic meetings/seminars/workshops for greater interaction.
