# A. IMPORTANT POLICY DECISIONS:

## (B) MAJOR ACHIEVEMENTS:

(i) National Pharmaceutical Pricing Authority (NPPA) has fixed retail prices of 7 new medicines during July, 2020 bringing cumulative figure to 1361 till July, 2020. (i.e. 52 in 2013-14, 108 in 2014-15, 124 in 2015-16, 157 in 2016-17, 234 in 2017-18 and 327 in 2018-19, 266 in 2019-20 and 93 up to July 2020 in 2020-21).

(ii) NPPA COVID-19 Control Room Activities:

NPPA set-up a Control Room with Helpline No. 1800111255 and <u>e-mail/monitoring-nppa@gov.in</u> on 20th March 2020 to respond to queries and complaints relating to COVID-19. Five officials/ officers had been deputed to attend the calls, 24 hours 7 days a week. The issues raised were addressed resolved, solutions were provided and forwarded to concerned authorities for redressal and followed up for final resolution.

State Drug Controllers had been identified as Nodal Officers for NPPA and had been directed to liaise with the District/ State authorities for ensuring resolution at ground level of the complaints received in NPPA's Control Room.

1863 calls from 28 States/ UTs were received in the Control room up to 31stJuly 2020. Issues relating to shortage/ overpricing of Masks, Sanitizers, medicines, issuance of permission of running of Pharma Units, movement of raw material/ packing materials/ medicines/ manpower etc. were addressed and resolved in co-ordination with concerned State Government authorities.

In certain specific cases (Delhi) the medicines were arranged to be delivered to the door steps of the people when these were not available in the vicinity.

(iii) Total overcharged amount received during July, 2020 is Rs. 60.01 Lakh.

(iv) 112 Jan Aushadhi Kendras under Pradhan Mantri Bhartiya Janaushadhi Pariyojana (PMBJP) were opened during **July**, **2020** across the country.
