Important events for the Month of March, 2021 are as follows:

(i) <u>IMPORTANT POLICY DECISIONS:</u>

Cabinet has approved proposal for amendment of NIPER, Act in its meeting held on 10.02.2021. Subsequently, amendment Bill introduced in Lok Sabha on 15.03.2021. Due to adjournment of Parliament before scheduled time, it could not be listed for discussion in Budget Session.

(ii) MAJOR ACHIEVEMENTS:

(a) The NPPA has fixed ceiling prices of 01 medicine during March, 2021 bringing the cumulative figure to 882 till March, 2021.

(b) Retail prices of 76 new medicines have been fixed during March, 2021 bringing cumulative figure to 1589 till March, 2021.

(c) Heparin Injection is considered as an essential drug for COVID management Accordingly, the revised price of Heparin Injection 1000IU/ml and Heparin Injection 5000IU/ml was extended up to 30.09.2021 or until further order, whichever is earlier, to ensure continuous availability especially during the pandemic situation of COVID-19.

(d) The price ceiling of Medical Oxygen was extended up to 30.09.2021 or until further order, whichever is earlier in view of continuing extraordinary circumstances due to the COVID pandemic.

(e) The ceiling prices of 882 scheduled formulations have been revised based on WPI applicable from 01.04.2021

(f) Price Monitoring and Resource Unit (PMRU) have been set up in 18 States against the target of 18 PMRUs consolidated by 2021-21, viz., Kerala, Gujrat, Odisha, Rajasthan, Punjab, Haryana, Tripura, Nagaland, Uttar Pradesh, Andhra Pradesh, Mizoram, Jammu & Kashmir, Karnataka, Telangana, Maharashtra, Goa, Madhya Pradesh and Chhattisgarh.

(g) Total overcharged amount received during March, 2021 is Rs. 40.86 Lakhs.

(h) 79 Jan Aushadhi Kendras under Pradhan Mantri Bhartiya Janaushadhi Pariyojna (PMBJP) were opened during March, 2021 across the country.

(i) Out of 622 Research Papers published during the current financial year, 74 papers has been published in March, 2021.

(j) Out of 37 Patents filed during the current financial year, 8 patents has been filed during the March, 2021.
