Notification

G.S.R.....- In exercise of the powers conferred by the proviso to article 309 of the Constitution, the President hereby makes the following rules regulating the method of recruitment to the post of Staff Car Driver in the Department of Pharmaceuticals, Ministry of Chemicals and Fertilizers, namely :-

**1. Short title and commencement.-** (1) These rules may be called the Ministry of Chemicals and Fertilizers, Department of Pharmaceuticals, Staff Car Driver (Group 'C' posts) Recruitment Rules, 2022.

(2) They shall come into force on the date of their publication in the Official Gazette.

**2. Number of post, its classification and level in the pay matrix.-** The number of post, its classification and level in the pay matrix attached thereto shall be as specified in the columns (2) to (4) of the schedule annexed to these rules.

**3. Method of recruitment, age - limit and qualifications, etc. -** The method of recruitment for the said post, age-limit, qualifications and other matters relating thereto, shall be as specified in columns (5) to (13) of the aforesaid schedule.

**4. Initial Constitution -** The incumbents holding the post of Staff Car Driver on regular basis immediately before the commencement of these rules, shall be deemed to have been appointed under these rules and their continuous service in the said post shall be taken into consideration for the purpose of qualifying service for probation, promotion and pension.

**5. Disqualification. -** No person,-

(a) who has entered into or contracted a marriage with a person having a spouse living; or

(b) who, having a spouse living, has entered into or contracted a marriage with any person,

shall be eligible for appointment to the said post:

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of these rules.

**6. Power to relax. -** Where the Central Government is of the opinion that it is necessary or expedient so to do, it may, by order and for reasons to be recorded in writing, relax any of the provisions of these rules with respect to any class or category of persons.



**7. Saving.** - Nothing in these rules shall affect reservations, relaxation of age - limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, the Other Backward Classes, the ex-Servicemen and other special categories of persons in accordance with the orders issued by the Central Government from time to time, in this regard.

		<p><b>Note :</b> The period of deputation including the period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organisation or Department of the Central Government shall ordinarily not exceed three years. The maximum age limit for appointment by deputation or absorption shall be not exceeding fifty-six years, as on the closing date of receipt of applications.</p>
