Subject: Review application of M/s Serum Institute of India Pvt. Limited against price fixation of their formulation "DPT Vaccine 0.5ml." vide NPPA order No. S.O. 1688(E), dated 24.05.2017 issued under Drugs (Prices Control) Order, 2013 (DPCO 2013).

Ref: 1) Review application dated 20.06.2017 2) NPPA notification under review S.O. No.1688(E), dated 24.05.2017 3) Record Note of discussions held in the personal hearing on 10.10.2017.

1. This is a review petition under paragraph 31 of the Drugs (Prices Control) Order, 2013 (hereinafter called the DPCO) filed by M/s Serum Institute of India Pvt. Limited (hereinafter called the petitioner) against notification S.O. No.1688(E), dated 24.05.2017 issued by the National Pharmaceutical Pricing Authority (hereinafter called the NPPA) fixing the ceiling price of their formulations DPT Vaccine 0.5ml.

2. The petitioner has contended as under:

(i) The ceiling price fixation and the computation is not as per the provision of DPCO, 2013 for the following reasons:-

a. While arriving at ceiling price of DPT 0.5ml the PTR and MAT details of all type of formulations i.e. Single and Multi dose formulation have been taken together.

In the computation sheet for Ceiling price of DPT 0.5ml Vaccine, PTR and MAT of DPT Injection 5ml which is a multi-dose formulation is taken together with PTR & MAT of 0.5ml vaccines.

b. The price of Single dose and Multi dose vaccine do not move in linear progression as purported to have taken in price working.

c. Similarly in the computation sheet PTR & MAT details taken of one manufacturer Biological E Ltd appears to be incorrect & they are no longer supplying DPT 0.5ml vaccines. Therefore there is a need to recalculate the ceiling price working under Para 18 (ii) & (iii) of DPCO 2013- revision of ceiling price on the basis of moving annual turnover (MAT).

(ii) Para 11(3) was inserted in the DPCO 2013 vide S.O. 1192(E) dated 22.03.2016, and states:

Notwithstanding anything contained in sub-paragraph (1) and (2), in the case of injections or inhalation or any other medicine for which dosage form or strength or both are not specified in the Schedule-I of the Drugs (Prices Control) Order, 2013, the Government may fix and notify separate ceiling price or retail price for such formulations with specified therapeutic rationale, considering the type of packaging or pack size or dosage compliance or content in the pack namely liquid, gaseous or any other form, in the unit dosage as the case may be, conforming to Indian Pharmacopeia or other standards as specified in the Drugs and Cosmetics Act, 1940 (23 of 1940) and the rules made thereunder for the same formulation.

(iii) Subsequently, a Committee of Experts was formed by Department of Pharmaceuticals as per the provisions of Para 11(4) of the DPCO to address the issue regarding single and multidose usage based on therapeutic rationale. As per the Minutes of the 3rd Meeting of the Committee held on 28.12.2016. the Committee had recommended for fixation of separate prices under Para 11(3&4) of DPCO 2013 for single and multi-dose formulations.

(iv) Company had already brought to the notice of NPPA stating the issues vide their letter dated 03/03/2017 in reply to the NPPA's draft version of the proposed calculation sheets for revised/ notified ceiling price/ retail of DPT Vaccine 0.5ml formulation vide office memorandum no.8(35)/2016/DP/NPPA-Div.-II dated 27th Feb 2017.

(v) In view of above, company requested this Department to once again review the Ceiling price working of DPT Vaccine 0.5ml taking into consideration of the above facts & issue a revised price notification accordingly.

3. Comments of NPPA:

I. Ceiling price of DPT Vaccine 0.5ml was notified as Rs. 12.85/ (0.5ml) vide S.O. 1688(E) dated 20.06.2017 as per para 4, 6, 10, 11, 14, 16, 17, & 18 of DPCO, 2013.

II. The company has stated that correct methodology was not followed in arriving at the ceiling price of **DPT Vaccine 0.5ml**. The points raised by the company are not relevant. Price fixation has been done strictly in accordance with the provisions of DPCO, 2013. Details are as follows:-

III. Company has not challenged S.O. No. 1688(E) dated 24.05.2017 in any Court.

4. During the personal hearing, the representatives of the company did not make any further submission.

5. <u>Examination:</u>

NPPA notified the ceiling price of **DPT Vaccine 0.5ml** vide SO 1688(E), dated 24.05.2013. Company contended to fix separate ceiling price for Single dose (0.5ml) and Multi-dose (5 ml) vaccine. On going through the submission made by NPPA, it is observed that NPPA had raised the matter in the 4th (continued) meeting of Committee of Experts under para 11(3&4) of DPCO, 2013 held on 02.05.2017 and the Committee recommended that separate ceiling price fixation for packs may not be considered. As the Expert Committee's recommendation has already been obtained and it has been recommended by the Committee not to fix separate ceiling price based on pack size, the request of company for separate ceiling price based on pack size cannot be agreed to. In view of this, the review application of the petitioner company may be rejected.

6. Government Decision:

"The Committee of Experts has recommended not to fix separate ceiling price of DPT Vaccine based on pack size. Therefore, the request of petitioner company for separate ceiling price of Single dose and Multi-dose DPT Vaccine cannot be agreed to, and the review application stands rejected."
