Please take reference to our DO letter dated 27th April, 2021 whereby an interim allocation of 3245 vials of Tocilizumab was made for States/UTs along with Central Institutions. As informed through the letter dated 27th April, 2021, Tocilizumab is sourced only through imports from a pharmaceutical company Roche, Switzerland and is marketed in India by Cipla Ltd. While the sale of Tocilizumab to various States/UTs is being undertaken by Cipla Ltd directly, the Central Govt is making all efforts and interventions to ensure that the drug is available across the country.

02. Accordingly, please find enclosed the revised allocation of Tocilizumab which will be placed at the disposal of the States for allocation to Government and Private Hospitals of the concerned State. It may be noted that 1200 vials have been allocated to the Govt of India which will be at the disposal of Ministry of Health and Family Welfare (MoHFW) for further allocation to the North Eastern States (including Sikkim), UTs and Central Govt Institutions. These respective States/UTs/Ministries of the Govt. of India may approach MoHFW in case of requirement of Tocilizumab. It is reiterated that no separate stock is being allocated directly to the private hospitals located in the States.

03. Further, it is to inform that the distribution is being done on an emergency basis looking only at the active case load in the States. The Government is making continuous efforts with the suppliers to further augment the supply through imports. The States are requested to make all efforts to prevent hoarding/black marketing and also ensure use the available vials of Tocilizumab judiciously and strictly according to the treatment protocol advised in the clinical guidance issued by Joint Monitoring Group of MoHFW.

04. The State Governments are requested to keep a record of the allocation made of the stocks placed at their disposal and make the information available at the request of the Govt. of India. State Governments are also requested to nominate a nodal officer for management of the allocated stocks and convey the details of the nodal officer (Name, Designation, Mobile, Email id) to the monitoring cell set up under Chairperson, National Pharmaceutical Pricing Authority at monitoring-nppa@gov.in.
